## Minutes of the Village of Forreston Board of Trustees Village Hall Monday April 15, 2024, 7:00 PM

President Metzger calls the meeting to order at 7:00 PM. The Pledge of Allegiance is recited by all.

On Roll Call by Clerk Shenberger, President Metzger, Trustee Norris, Trustee Cotter, Trustee Vinnedge, Chief Thiel, Maintenance Supervisor Timm, Treasurer Schneiderman, Trustee Buss, Trustee Busker, and Trustee Kalina. One member from the public.

## Consent Agenda:

Accounts payable is removed from the consent agenda.

Motion is made by Trustee Vinnedge to approve the consent agenda and is 2<sup>nd</sup> by Trustee Norris. All are in favor.

Public Comment – Courtney Warren gave an update from CFPS. She stated Fischer was the lowest bidder for phase 2. IEPA is looking at that now and will put together loan documents.

Building Permits – 611 S Walnut Ave – 2-part permit. 1<sup>st</sup> is a demo of an existing garage. The garage is leaning and needs to come down. This is a no charge permit. Motion is made by Trustee Cotter to approve the demo of the garage and is 2<sup>nd</sup> by Trustee Buss. On Roll Call, Trustees Norris, Cotter, Vinnedge, Buss, Busker, and Kalina all respond with Yeas. The 2<sup>nd</sup> part of the permit is a new garage. This will be a 24x50 garage. This is over the 900 square foot maximum so this will have to go to the planning commission for a variance.

## Department Reports:

Supt. of Public Works Report – Maintenance Supervisor Timm reviewed his report. He stated the bathrooms are open at both parks now. They swept and washed floors at 407 N Locust and marked curb stops and storm sewers for phase 3. They put the batting cage net up and cleanup up yards from snow plowing. They started mowing and trimming and hauled brush. They also ran the press and fixed the defrost motor on Kevin's truck. They raked and cleaned up parks and cleaned up storm sewers. He also stated they hired part time help for the summer.

Chief of Police Report – Chief Thiel stated Blake and Hannah attended the funeral and procession for the Dekalb County Deputy who was killed on duty in a traffic accident. Officers attended a Shining Star interview with Polo Police Department regarding an allegation of battery and neglect from multiple students. This incident is still under investigation. Officers responded to a possible suicide attempt. Forreston EMS transported the juvenile and the School District was also advised of the incident. Officers also responded to a check welfare call and a male was found deceased upon arrival. Forreston EMS and Ogle County Coroner's Office were also dispatched to the scene.

Clerk's Report – Clerk Shenberger stated we got the approval for the clean up days grant. She also stated Sonia's last day will be May 31st and she will be cutting her hours down from here going forward until her last day. She also discussed the possible sale of Josh's Saloon and the new owners getting a liquor license.

## Committee Reports:

Streets & Alleys - Trustee Buss - Nothing to report.

Sewer and Water – Trustee Vinnedge stated there have been some sewer issues on 2<sup>nd</sup> avenue and Fischer's is going to come dig it up to find and fix the issue. It will be about \$10,000.

Finance - Resolution 2024-06 – Authorizing a budget increase for payment of prior water system improvements. Motion is made by Trustee Busker to approve the Resolution and is 2<sup>nd</sup> by Trustee Kalina. On Roll Call, Trustees Kalina, Busker, Buss, Vinnedge, Cotter, and Norris all reply with Yeas.

2024-03 Budget Ordinance – Motion is made by Trustee Busker to approve the ordinance and is 2<sup>nd</sup> by Trustee Norris. On Roll Call, Trustees Norris, Cotter, Vinnedge, Buss, Busker, and Kalina all respond with Yeas.

Buildings, Grounds, Parks, Zoning, and Planning - Trustee Cotter nothing to report.
