Department Reports:

Supt. of Public Works Report – Maintenace Supervisor Timm reviewed his report. He stated they have continued brush pickup and have also been picking up the stump grinding. They put dirt in and seeded where stumps were ground. They sprayed the parks and cemetery for weeds and also flushed hydrants. They also mowed and trimmed and planted trees. The generator guy will be here in June to get the electric run. He stated clean up days went well this year. He also got the new truck ordered through Jeremy.

Chief of Police Report – Chief Thiel stated officers responded to a welfare check called in by an employer. The employee was ok just overslept. They also responded to a neighbor dispute and a suicide attempt. Officers responded to a disturbance call. The victim stated a male went to her house and interrogated her about her dogs matching the description of an incident in which a dog bit a female. The victim did not wish to press charges and the dogs were not the correct breed or color. Chief Thiel stated they had just had the bike rodeo and it went well! He is working on a taser grant to update tasers. He also stated there are two FEMA grants out there right now that would pay for generators and another bathroom to finish making the Village Hall the headquarters in case of a natural disaster. He stated Polo approached us with an inner agency agreement. If they need backup or we do, we could back each other. He stated Mt. Morris and Oregon have something like this in place. He will see what the agreement says and then present it to the board.

Clerk's Report – Clerk Shenberger gave an update on Gworks software. They have another IT employee working on the issue.

Streets & Alleys - Trustee Buss nothing to report.

Sewer and Water – Trustee Vinnedge nothing to report.

Finance - Trustee Busker is absent.

Buildings, Grounds, Parks, Zoning, and Planning – Trustee Cotter stated the ball fields are being used. Lots of kids out and about. He stated there was an issue with a cooler in the concession. Parks will pay for it and then be reimbursed from a donor.
