Committee Reports:

Streets & Alleys - Trustee Buss nothing to report.

Sewer and Water – Trustee Vinnedge asked when Martin was coming back. Maintenance Supervisor Timm stated they would be back this month and done by November 1st.

Finance - Trustee Norris stated that the finance committee met on September 29th. She went over the meeting minutes. She also reminded everyone that it is that time of the year that if you want to give raises it is the time to give raise evaluations. Motion is made by Trustee Norris to approve a donation of \$500 to the organization that helped with the cats in town and is 2nd by Trustee Vinnedge. Buildings, Grounds, Parks, Zoning, Planning - Trustee Cotter stated he is waiting on the Lions Club to see what they can find out from Ogle County to see if they can go with a smaller sink with a small grease trap. He stated that they did put the GFI outlets in.

Supt of Public Works Report – Maintenance Supervisor Timm stated they hauled brush and flushed hydrants. They helped pull out cabinets at Warnken concessions. They also took out bushes at the library for the internet towers and dug and vac the holes as well. They cleaned the shop and greased and washed equipment. He stated Porter Bros are back sweeping the streets that were seal coated. Trustee Buss asked Supervisor Timm what his timeline was to get the concreate cleaned up at our yard waste site. Supervisor Timm stated he is working on it.

Village President's Report – President Metzger wanted to thank everyone for their hard work on the New Village Hall. He talked about a project that the school was going to be doing over the summer on the bus lanes. President Metzger went over an email he received from Pepin about phase two water main replacement.

New Business – Approval of Notice of Award to Quad Cities Winwater for Loan 17-5892 in the amount of \$195,974. Motion is made by Trustee Vinnedge to approve the award and is 2nd by Trustee Kalina. On Roll Call, Trustees Norris, Cotter, Vinnedge, Buss, Busker, and Kalina all respond with Yeas.

Leaf River Communications Contract and Ordinance – Motion is made by Trustee Vinnedge to approve the contract and ordinance with any changes our attorney may have on them, 2nd by Trustee Kalina. On Roll Call, Trustees Cotter, Vinnedge, Buss, Busker, Kalina, and Norris all respond with Yeas.

Discussion of prize drawings for open house – Discussion was had on ideas for drawings for the open house at the new village hall. It was discussed to do a drawing for money off water bills.
